

OFFICIAL CALL

Mass Meeting of the Republican Party of Virginia Beach City Committee of the Republican Party of Virginia

As Chairman of the Republican Party of Virginia Beach Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Tina Mapes, do hereby issue this call for a Mass Meeting to be held at Virginia Beach Law Enforcement Training Center, 411 Integrity Way, Virginia Beach, VA 23451, or its alternate location, starting at 11:00 a.m. local time on Saturday, April 21, 2018 for the following purposes:

- a) Electing a Chairman of the Republican Party of Virginia Beach City Committee;
- b) Electing members of the Republican Party of Virginia Beach City Committee;
- c) And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of the City of Virginia Beach, Virginia under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements for Candidates for Chairman

Candidates for Republican Party of Virginia Beach City Committee Chairman shall file the RPVB Official Filing Form declaring their candidacy for the election or nomination at said mass meeting by mail or in person to Ann Garrett, RPVB, 2955 Virginia Beach Blvd, Ste. 105, Virginia Beach, VA 23452, which must be received not later than 12:00 noon on Tuesday, March 20, 2018. Postmarks do not govern. Contact information for Ann Garrett is 757-752-7428.

Forms are available on the Republican Party of Virginia Beach website (www.rpvb.org).

Only those who have properly Pre-Filed can be nominated at the Mass Meeting. No nominations may be made from the floor of the Mass Meeting for City Committee Chairman by virtue of the pre-filing requirements. If no more than one candidate files for election to the office of Unit Chairman to be voted upon at the Mass Meeting, that candidate will be declared duly elected and the mass meeting will be cancelled.

Mass Meeting Registration

Registration to participate in the Mass Meeting may be prepared in advance and mailed to Ann Garrett, RPVB, 2955 Virginia Beach Blvd, Ste. 105, Virginia Beach, VA 23452.

“Official Filing Forms” are available at www.rpvb.org. Registration may also be accomplished immediately prior to the Mass Meeting. However, persons wishing to be elected as a member of the Republican Party of Virginia Beach must pre-file their Official Filing Form, along with the mandatory, non-refundable, membership fee of \$50.00, payable to Republican Party of Virginia Beach, no later than Monday, April 9, 2018 at 5:00 p.m. Postmarks do not govern.

On the day of the Mass Meeting, doors will open at 10:00 a.m. and close at 11:00 a.m. Anyone who meets the requirements for participation and is in line by 11:00 a.m. will be registered.

There is no registration fee to participate in the Mass Meeting. Voluntary contributions are welcome to help defray the expenses. Checks should be made payable to the Republican Party of Virginia Beach.

Should the Mass Meeting be canceled, all qualified persons who have properly filed and paid by April 9, 2018 at 12:00 noon shall be deemed elected as members of the Republican Party of Virginia Beach.

Call Revisions

The City Committee Chairman is authorized to revise the issued Call to make any such technical or conforming changes in the event such changes are necessary. The City Committee Chairman must promptly notify the City Committee of any such technical or conforming changes.

Publication of the Call

The Mass Meeting Call will be posted online as permitted by the Republican Party of Virginia and distributed by other electronic means. Newspaper publication is waived.
