

**OFFICIAL CALL**  
**Legislative District Party Canvass**  
**of the 82<sup>nd</sup> House**  
**District of the Republican Party of Virginia**

As Chairman of the 82<sup>nd</sup> HOUSE District Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, John C. Atkinson, do hereby issue this call for a Legislative District Party Canvass to be held at Galilee Church, 3928 Pacific Ave, Virginia Beach, VA, VA 23451, from 10:00 am to 3:00 pm local time on Saturday, June 5<sup>th</sup>, 2021, for the purposes of:

(a) Nominating a Republican candidate for the office of DELEGATE to be voted for in the GENERAL election on November 2<sup>nd</sup>, 2021.

**Qualifications for Participation**

All legal and qualified voters of the 82<sup>nd</sup> HOUSE District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

**Filing Requirements for Candidates**

Candidates for the Republican nomination at said canvass shall file with the Legislative District Chair in person, to John C Atkinson, the following items.

1. 82<sup>nd</sup> House District Canvas Candidate Filing Form
2. A non-refundable Filing fee of Seven Hundred Five Dollars and sixty cents (**\$705.60**) made payable to the "Republican Party of Virginia Beach" (RPVB)

Any person who desires to seek the nomination as the Republican candidate for the 82<sup>nd</sup> House District, General Assembly of Virginia, must deliver the above items to the LDC on Friday May 21<sup>st</sup> 2021 between 12:00 p.m. and 5:00 p.m. at 932 Laskin Road, 3<sup>rd</sup> Floor, Virginia Beach, VA 23451. *If only one candidate properly files, then said candidate shall be declared the Republican nominee and no canvass will be held.*

**Registration and Fee**

There will be no pre-registration or fee for eligible voters to participate in this canvass.

Any persons with a religious exception to the date of the canvas may contact the LDC no later than Monday May 31<sup>st</sup> 2021 5:00 P.M. for special voting instructions. Mr. Atkinson may be reached at 757-285-7055.

**Newspaper Announcement**

The Legislative District Committee has agreed to waive the publishing of the call in a local newspaper.
