

OFFICIAL CALL
Legislative District Party Canvass
of the 84th House
District of the Republican Party of Virginia

As Chairman of the 84th HOUSE District Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, William Curtis, do hereby issue this call for a Legislative District Party Canvass to be held at 2955 Virginia Beach Blvd., Suite 105, Virginia Beach, VA, 23452, from 4:00 pm to 8:00 pm local time on Wednesday, June 2, 2021, for the purposes of:

(a) Nominating a Republican candidate for the office of DELEGATE to be voted for in the GENERAL election on November 2, 2021.

Qualifications for Participation

All legal and qualified voters of the 84th HOUSE District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for the Republican nomination at said canvass shall file a written statement by mail or in person, to William Curtis, 2955 Virginia Beach Blvd, Suite. 105, Virginia Beach, VA 23452, which must be received not later than 5:00 p.m., 24 May, 2021. *If only one candidate properly files, then said candidate shall be declared the Republican nominee and no canvass will be held.*

Any person who desires to seek the nomination for the Republican candidate for the 84th House District, General Assembly of Virginia, must deliver a Candidate Filing Form along with a non-refundable filing fee of **seven hundred five dollars and sixty cents (\$705.60)** to the Chairman of the Legislative District Committee for the 84th House District, William Curtis, or his designee **by 5:00 p.m., May 24, 2021 at 2955 Virginia Beach Blvd., Suite 105, Virginia Beach, VA 23452.**

Registration Fee

There will be no registration fee to participate in this canvass.

Newspaper Notification

The 84th Legislative District Committee has agreed to waive publishing the call in a local newspaper.
